

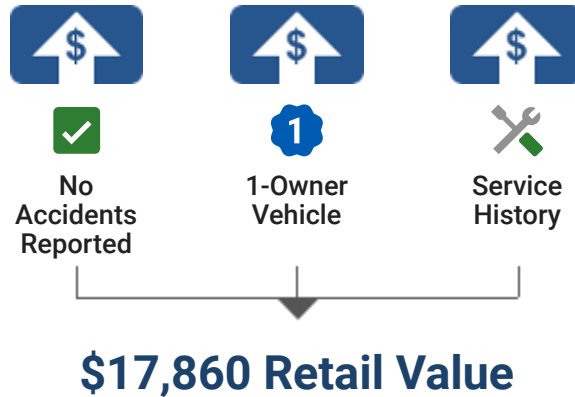

Ownership History
